Unshared Amount 1500/3000/6000	Eligible bills are shared 100% after Unshared Amount, per Sharing Request basis, with a safeguard limit of two maximum in 12 months. No cap on sharing limit per Sharing Request
Payment Options	Members can receive a debit card by email to pay for services or request a reimbursement.
Pre-existing Limitations	No sharing available in year 1 of membership for care not related to preventive sharing.

Medical Conditions Existing Prior To Membership ShareWELL members have a waiting period for medical conditions that existed before the membership start date. A pre-existing medical condition limitation is applied based on the first date of active membership.

Any illness or injury for which a person has had any of the following occur:

- *Been examined*
- *Taken medication*
- *Had symptoms*
- *Received medical treatment*

Within 24 months prior to the effective date of the membership is considered a pre-existing condition.

Mental Health Emergency- panic attack, anxiety, bipolar, insomnia, paranoia, depression, overdose	Expenses for the first 24 hours of hospitalization are eligible once per member per lifetime of the membership with a \$10,000 sharing allowance.

Testing	How it works
Allergy testing (including serums, injections, and administration)	<i>Treatment for the relief or reversal of the long-term effects of an allergy is eligible after an initial pre-existing waiting period of up to a one-time allowance of \$2,000.</i>
Sleep Studies	<i>Eligible only if it is required to treat an approved Sharing Request</i>
Genetic Screening & Testing	<i>Eligible only if it is required to treat an approved Sharing Request, such as breast cancer.</i>

Ambulance air or ground for emergency	<i>Meet Unshared Amount</i>
Chemotherapy	<i>Meet Unshared Amount</i>
Dialysis and supplies	<i>Meet Unshared Amount</i>
Durable medical equipment (including orthotics/prosthetics)	<i>Meet Unshared Amount, 180 days from the treatment start date, Medical supply costs must be over \$50 per item, with a maximum allowance of \$3,000 per Sharing Request</i>

Home health services	<i>Meet Unshared Amount, allowance of \$3,000 per Sharing Request.</i>
Hospice services	<i>Meet Unshared Amount, eligible for 60-day periods with certification of terminal illness</i>
Medications prescribed after membership start date with no prior symptoms	<i>Meet Unshared Amount, Sharing in all prescription costs is limited to 12 months per Sharing Request.</i>
Contraception	<i>Eligible only if it is required to treat an approved Sharing Request.</i>
Sleep Apnea	<i>Expenses related to sleep apnea are eligible after the initial pre-existing waiting period with a one-time allowance of \$2,000.</i>
Alternative care services	How it works
Acupuncture	<i>Meet Unshared Amount, \$3,500 recovery allowance per Sharing Request</i>
Chiropractic care	<i>Meet Unshared Amount, \$3,500 recovery allowance per Sharing Request</i>
Alternative Treatments	<i>Meet Unshared Amount, Treatments that do not have a proven conventional treatment will be eligible for a one-time allowance of \$2,500</i>
Alternative Testing	<i>After the initial pre-existing waiting period, Meet Unshared Amount, all alternative testing programs and expenses are eligible, with a one-time allowance of \$2,000</i>

Dental & Vision	How it works
Vision	<p><i>Vision hardware-related expenses, such as glasses and contacts, are ineligible for sharing. Expenses to correct refraction, including but not limited to Lasik, PRK, lens implants, and/or other surgical or non-surgical visual acuity procedures and treatments unrelated to cataract surgery, are also ineligible for sharing.</i></p>
Dental	<p><i>Dental services such as caps, crowns, root canals, fillings, wisdom tooth extraction, anesthesia, sedation, and cleanings are not eligible. However, tooth damage caused by an accident or injury (e.g., a car accident) may be considered for sharing.</i></p>
Maternity	How it works
Waiting Period	<p><i>Conception occurring within (30) days of the membership start date is ineligible for sharing</i></p>
Prenatal & Postnatal Allowance	<p><i>\$6,000 sharing allowance: Includes: Doula, Doula Tub, Prenatal vitamins, Midwives, Immunizations for the mother, Pelvic floor services, Routine office visits Routine lab work, Fetal non-stress test (after 36 weeks) 2D, 3D, or 4D ultrasounds STD/STI screenings prescribed as part of routine prenatal care, Gestational diabetes, This includes care and medications related to treatment, breast pumps, lactation consultant, postpartum counseling, acupuncture, chiropractic care, 6-week post partum checkup, and 2 week cesarean post-op appointment.</i></p>

NICU (Neonatal Intensive Care Unit)	<i>For NICU admission the time limit for sharing is 35 days after birth.</i>
Newborn Congenital Conditions	<i>For children born from an eligible Maternity Sharing Request, sharing is limited to \$125,000 for medical bills related to congenital conditions after the initial hospital discharge.</i>
Diapers	<i>six-month supply of disposable diapers after delivery.</i>
UA Reduction Maternity Program	<i>Members with costs not exceeding \$10,000 for delivery, post-natal, and pre-natal expenses. ShareWELL will reduce the Unshared Amount responsibility by \$1,000.</i>
